

have been tickled, but I've never had a sabbatical in my life. I've taught 50 years steady. Before this I would have been tickled with it but now I'd rather wait until I'm ~~x~~ through. McIntire says, You'll never be through!

So we continued on. The (age) 65 was passed by; it was nothing of any importance, and I simply continued. McIntire would come over and give us one or two chapel talks a year. He would present the issues: the terribleness of modernism, the actions of the WCC in its trying to advance communism and trying to destroy all we believe in. I was 100% behind those things though I did not think they should be everything. I think they should be a part of our activity, but I thought what he said was excellent.

He come once or twice a year, then he was at the director's meetings. At them he spent most of his time discussing finances or discussing who was --how many of our students had become Bible Presbyterians. With Steele out of the picture it sounded as if as long as I lived I'd be there.

In 1968 he began to get more dictatorial. We hired a graduate to represent the seminary, to go around and talk to students and go to colleges and help reach people. Our treasurer, Mr. Currey, rented (him) a car for 2 years. At the end of a year in '69 at the Board meeting, Dr. McIntire said, We hired this man for one year and we are through with him. We had him for a year, now we are through! We would never have rented a car for 2 years if we had not hoped a longer arrangement than one year. I said, Well let's discuss this. He said, There is nothing to discuss. He was hired for a year and he's finished. The attitude he took at that meeting, I'd never seen anything like it before.

If I'd go into a meeting, from the very beginning I would present an argument for something, he would say, That's impossible! The Board would all know if was impossible then, of course. That was sufficient argument. Or he would say, That stands to reason. But he did not (even) do that now. He said, We are not discussing it(this). The thing was that one or two people had ~~as~~ said that this fellow had said things critical of Dr. McIntire as he went around. I don't know whether there was any truth to it or not. He claimed there wasn't any truth. But McIntire said to me later, He's a blabber mouth. He said, He might be alright after a while. But he said, We don't want him in any position like this now. I think he went over and worked for a while in the Beacon office. afterthat.

Anyway, the way he did that so disgusted me that I walked out of the meeting. I walked out and went over to my house(which was a little fruther than here) and I was all upset. I waited for a few minutes and then I drove off about 6 or 7 miles and went for a walk. About an hour later someone came over looking for me and did not find me.
