in his life were when Dr. Machen died, and when Charlie Woodbridge left them. But Charlie went down there and in the presbytery told how all his ancestors had been Southern Presbyterians, etc., and so he was received into the presbytery. He had churches there for 5 or 6 yrs., then went to Fuller Seminary and was Dean of Students for 3 yrs.(was there 6 yrs, I think). He got a food salary at Fuller and he made just as much more speaking in Bible Conferences every week-end.

He used to travel all over through Utah, Nevadak and around and had quite a circut he made. Then he became Wyrtzen's right hand man, and taught at Word of Life every summer for a long time. I think McIntire said he had gone full circle and had come back to us. He was entirely with us. I think they were hoping he could take over Shelton after Steele left. He wasn't interested in that.

But now McIntire says, Let's get Woodbridge to come and speak to the students this spring. See. He was so enthused about getting him to come that I phoned to California and got Woodbridge to come and he agreed to come and speak the next November and speak in chapel long periods. Then I suggested, Cantt you come and give us a week now? Well, he said, three weeks from now there is a week I'm free I could come for that week. So I said, Fine, come for that week.

He came. I met him at the airport, brought him up and put him in our guest room at the seminary which was very palatial. The women of the school spent loads of money fixing up this guest room which was hardly used. He was in that. He spoke in chapel. He began taking an attitude. Well, he told me, I haven't talked with any student unless there was a faculty member present. But we had him to dinner one noon with members of the faculty, and he said to Harding, I'll be back in Phila. next Nov. but I'm not going to speak here. He said, I couldn't speak here unless two of those faculty members were fired. I said, Who? He said, Those tow that were sitting at that end of the table. That was Dunzweiler and Vannoy.

How would he know anything about them if he never talked to any student? ((Maybe he talked to McIntire)). His last day, I think Friday, Mr. Taylor was just leaving for a trip through Southern colleges, and one of the other faculty members was away somewhere and anyway there was nobody in chapel but myself of the faculty. He asked all faculty members present to raise k their hands. Why arh't they here?(Woodbridge asked). He just took a strong stand. I said to somebody, Where did he get all these ideas? He says he hasn't talked with anybody without a faculty member being present.

Eppard was eating his meals there. His home was in Wilmington. Ken Lee. He went into Ken Lee's room and Eppard went with him. And Eppard was there. Eppard all through these years was a man who did not speak out much and let you know what he thought on things. He spoke nice and you kind of thought he was with you, but you were not always 100% sure. Eppard may have been there and Eppard should have come and told me about it. He didn't say a word about it. But Woodbridge took this strong attitude, and talked to me how terrible it was
