

them look good, and then they had a trial fo which they invited Germans from all over Europe. They came to hear the leaders of the Protestant churches give their testimony. One after another they spoke the words that had been drilled into them like a tape recorder, he said. They all confessed to terrible crimes and in the end the four top leaders were sent to prison for life; others for various lengths of years, and Popov himself for 15 years of further torture.

Christianity Today just recently [Dec. 13, 1985] tells about the director of Campus Crusade in Nicaragua. He was a lawyer who had been a judge in the Nicaraguan criminal court. In 1982 he became national director of Campus Crusade. One day, Christianity Today says, the officials summonsed him to appear for possessing counterrevolutionary literature. When he asked what counterrevolutionary literature he had distributed they showed him a copy of "The Four Spiritual Laws." They then took him with them to the state security office, ofdered him to give them all the evangelistic booklets he had confiscated 2,000 of the Four Spiritual Law ~~booklets~~ booklets. They went to the printshop where they found 50,000 more. The confiscated and destroyed all of these and ordered the owners of the press never to again print materials for us under the threat of being taken immediately to jail. He was submitted to torture and taken to a room where he saw the local leaders of Campus Crusade all standing naked in the room which he passed through. He was released after having been given a terrible scare. He was ordered not to leave the country but through a mistake he received permission to go. He has told about it in Washington, Exactly what happened in Bulgaria is now happening in Nicaragua. Communism is sworn to conquer the world. That is its purpose; its declared goal. But they never procede on just one line. They work every possible line. Their propagandists have been working to soften people up. "Oh we should negotiate, negotiate, negotiate." How can you negotiate with a man who is holding a gun at your head and ~~that~~ threatening to kill you/ How can you negotiate with the leaders of Nicaragua who are carrying out the same policies that were carried out in Bulgaria and elsewhere. It is nonsense, but the people have been brainwashed. Maybe they won't succeed in getting nuclear armaments strong enough that we will have to ~~suffend~~ surrender before a threat of nuclear destruction. There will be no nuclear destruction. Nobody wants nuclear destruction. But get the nuclear power anything like the
